EDITORIAL BOARD DECISIONS

At the regular session of the Editorial Board of the international scientific journal, Archives of Biological Sciences (ABS), held on 8 November 2010, the following were unanimously agreed upon:

DECISIONS

- Art. 1. Scientific manuscript by Maja A. Karaman, Neda M. Mimica-Dukić and M. N. Matavulj was published in 2005 in the Archives of Biological Sciences, Vol. 57 (2), 93-100. This same paper was published in 2010 in the Central European Journal of Biology, Vol. 5 (4), 491-495. Considering this to be an unequivocal instance of autoplagiarism, the ABS Editorial Board took the unanimous decision to inform Maja A. Karaman that the submission of any future work to this Journal for consideration of publication is not recommended.
- Art. 2. Scientific manuscript by B. S. Ashok Kumar, K. Lakshman, K. N. Jayaveera, D. Shekar Sheshadri and C. Vivek was published in 2010 in the Archives of Biological Sciences, Vol. 62 (2), 397-402. This exact same paper was published in 2009 in the Avicenna Journal of Medical Biotechnology, Vol. 1 (3), 167-177. Since this is a case of manifest autoplagiarism, the ABS Editorial Board decided not to accept any future papers from the above-mentioned author for consideration of publication.
- Art. 3. Scientific manuscript by Tatjana Mihajilov-Krstev, Dragan Radnović, Dušanka Kitić, Zorica Stojanović-Radić and Bojan Zlatković was published in 2010 in the Archives of Biological Sciences, Vol. 62 (1), 175-183. This same work was once again published in Biotechnology & Biotechnological Equipment in 2010, Vol. 23 (4), 1492-1496. Considering this to be a case of autoplagiarism, future manuscripts by Tatjana Mihajilov-Krstev are not welcome for consideration of publication.
- Art. 4. Scientific manuscript by Dragana Stanojević, Ljiljana Čomić, Olgica Stefanović and Slavica Solujić-Sukdolak published in 2010 in the Archives of Biological Sciences, Vol. 62 (1), 175-183 presents an instance of autoplagiarism of a work by the same authors published in the Central European Journal of Biology, Vol. 5 (4), 491-495. As a result, further communication with the ABS Editorial Board by the first author is not recommended.
- Art. 5. The scientific manuscript of V. Rajković, M. Matavulj and D. Vučković, published through technical error in the Archives of Biological Sciences in 2010, Vol. 62 (2), 347-349, having already been published in Vol. 62 (1) of the same journal, is hereby withdrawn.
- Art. 6. Scientific manuscript by M. Kojić, Jelena Lozo, B. Jovčić, Ivana Strahinjić, Đ. Fira and Lj. Topisirović, published in 2010 in the Archives of Biological Sciences, Vol. 62 (2), 231-243, is hereby withdrawn from this journal due to a printing error whereby the figure legends, essential to the full presentation of the study's scientific information, were omitted.
